### **SUMMARY JOB DESCRIPTION**

*Cleans new and previously used trucks. Adheres to the descriptive estimates and work time prescribed by the dealer and/or the manufacturer. Applies the appropriate aesthetic treatments, based on superior quality standards.*

**The MAJOR TASKS** are listed below, but the incumbent may be assigned to other duties.

- Washes the outsides of the trucks, washes the windows inside and outside and wipes the hold-open mechanisms.
- Applies wax to the bodywork and wipes or buffs the surface with non-abrasive products.
- Vacuums the trucks inside to remove dust and debris.
- Cleans the upholstery, carpets and other surfaces, using appropriate cleaners, applicators and cleaning equipment.
- Applies revitalizers and preservatives to interior vinyl or leather surfaces and treats fabrics with spot removers.
- Cleans the engine and engine compartment with special cleaning equipment and various cleaners.
- Applies special purpose cleaners to remove foreign materials which do not respond to ordinary cleaning procedures, using his/her experience and judgment and following the manufacturer's recommendations.
- Inspects the vehicles to detect any visible defects, such as bumps, scratches or torn upholstery.
- Refurbishes the engine compartment, carpets and upholstery.
- Applies dressing to the tires and the walls of the tires.
- Ensures that the truck wash and outside garage are clean and in good condition at all times.
- Inspects the eyewash fountains once a week to ensure that they are clean and working properly.

- Tests the drench shower once a week to ensure that it is working properly.
- Constantly checks the accessibility of the area in which the drench shower is located.
- Ensures that cleaning products and fluids, as well as certain accessories, are available, on a daily basis.
- Removes all stickers from the trucks sold.
- Ensures that the shop is clean and tidy.
- Wears appropriate safety gear to protect his/her eyes, hands and body when using hazardous products.
- Uses all tools and equipment carefully.
- Participates in identifying hazardous products.
- Reports any safety issue to management, as soon as possible.
- Keeps abreast of federal and provincial regulations and municipal bylaws governing matters such as the removal of hazardous waste, etc.; understands and observes them.
- Maintains a professional appearance.
- Performs other tasks, based on management requirements and instructions.
